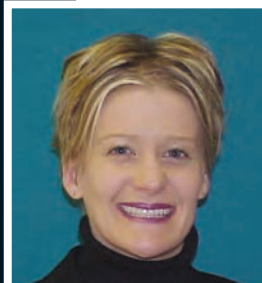
Over the past 25 years, the Foundation has raised over \$5 million in support of hospital and community health programs.

Unveiling and 'Thank You' Event

More than 100 community members, board members, staff, physicians, donors, volunteers and friends joined the St. Francis Foundation this past September to celebrate its 25th anniversary. The event recognized, honored and thanked the many individuals who have played such a vital role in the Foundation's history since its inception in 1982. St. Francis has benefited greatly over the years from a strong tradition of philanthropic leadership. To date, more than 25,000 community members have invested their time, talent and resources to help raise more than \$6.4 million for hospital and community health programs.

Legacy of Giving and Community

As part of the event, the St. Francis Foundation unveiled its new Donor Wall, which recognizes annual and lifetime giving. Shakopee resident Bert Notermann, former Foundation and Hospital

and Director, participated in the unveiling and shared personal thoughts and memories of when he served as Chairman of the original campaign to build the new hospital. A prayer and blessing was led by Father Steve Ulrick.

During the celebration, attendees paid tribute to the hospital's new Legacy Wall. The captivating structure offers a timeless collage of pictures, prayers and artifacts carefully chosen to tell the story of how people in the area used the land and innovations to build the community. It also illustrates the struggles and joys that were a part of that journey.

Donors Tour Healing Artwork

Funded by donors through the St. Francis Foundation, many organizations, groups and individuals contributed to the Legacy Wall's formation, including an employee committee, the St. Francis auxiliary, the Shakopee Mdewakanton Sioux Community, the Benedictine Sisters of Duluth and Franciscan Sisters of St. Paul, Scott County and the Minnesota Historical Societies, as well as senior leadership and St. Francis physicians.

St. Francis President Michael Baumgartner dedicated the wall with the words of St. Benedict: "Care of the sick must rank above and before all else. That is why we are here, to care for our patients, when patients and families are at their most vulnerable times. It is our sacred trust."

A June 'thank you' event brought Foundation donors together for a tour of the new artwork in the hospital's Care North conference rooms. Donor support helped make the artwork possible. During a hospital tour, guests visited new donor plaques recognizing gifts to the Foundation. The newly commissioned conference room artwork reflects the hospital's values and bear the same name — Joy, Hospitality, Partnership, Justice, Stewardship and Respect.

Led by art and design consultant Victoria Hovde, St. Francis has been engaged in a healing arts program since the new hospital was built in 1996. Hovde integrated art from the former hospital throughout the campus. Artist, Jodi Reeb-Myers, describes each piece of art and her inspiration for each individual value.

Fund for Excellence Awards First Grant

The St. Francis Foundation's Fund For Excellence (FFE) has awarded \$200,000 to support the development of a new Hospitalist Program at St. Francis. This is the first grant through FFE, a fund established in 2007 to ensure that assets are in place for St. Francis to rapidly respond to immediate and strategic opportunities to deliver better health care and sustain excellence into the future.

The Hospitalist Program will expand physician coverage by bringing on board generalist physicians to support surgical sub-specialists and medical sub-specialists, allowing for the most appropriate physicians at the bedside. The Foundation's substantial grant will help start the Hospitalist Program in 2008.

Reflections of Silver...Visions of Gold

Supporters of the St. Francis Foundation continued to celebrate 25 years of service during the 2007 Foundation Gala at Oak Ridge Hotel and Conference Center. More than \$175,000, including in-kind donations, was raised to support the healing environment at St. Francis, which included enhancing four rooms used for pediatric patients and creating a new Atrium Garden for employees, patients and families. 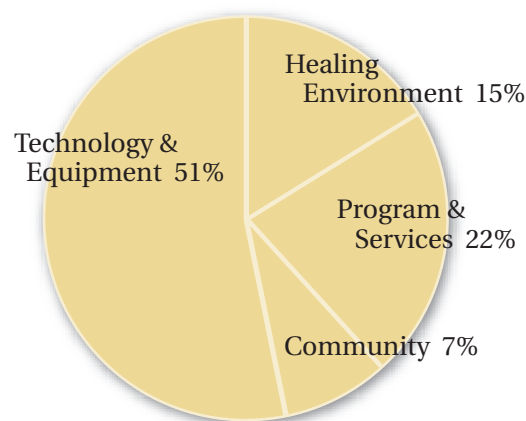
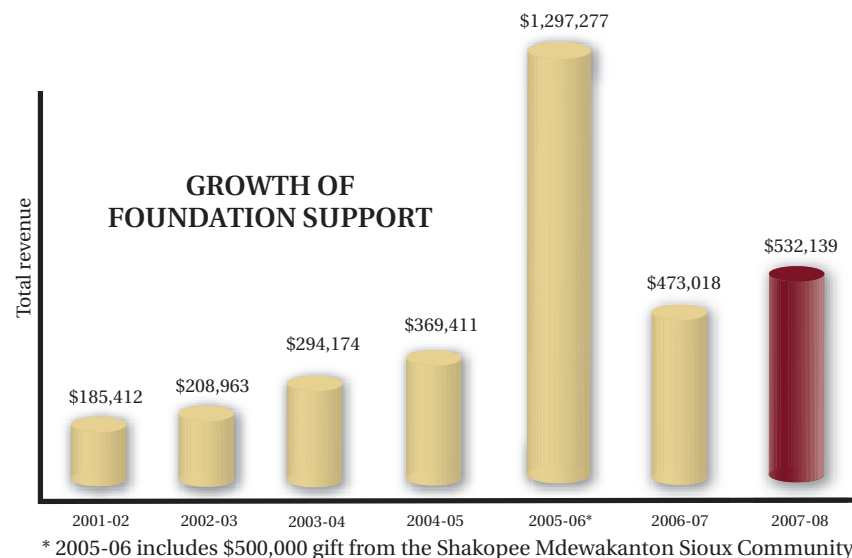
